P/2016/00550 - This is the application for the change of use from golf course fairway to agricultural land, Former Craythorne Golf Club, Craythorne Road.

P/2016/00768 – Linked extension from the house to the garage. As a consensus could not be reached by Councillors, and objections raised by local residents, a Planning Sub-Committee meeting was called for Monday 4th July.

P/2016/02685 - Erection of a part two storey part single storey side extension, erection of a dormer extension to the rear elevation, widening of existing access and erection of entrance gates. The Cedar Cottage, Hall Grounds.

6. CORRESPONDENCE RECEIVED

Email received from a visitor

The gate on the footpath that leads to the playing field behind Beacon Road is not at all user friendly for parents using pushchairs (picture attached) and this means that if it is necessary to walk from The Co-operative Shop on Burnside to the butchers on Chapel Lane, then the route that has to be followed has to be down Burnside to Station road, then turn left until Chapel Lane is reached on the right hand side.

This is a distance of at least 0.7 miles. The alternative route via the playing field and Beacon Road is considerably shorter, and in many cases time is of the essence for young mothers and their charges!

If a way was found of incorporating a gate such as that found on the Jinnie Trail at Bridge Street in Stretton at this point it would make life much easier.

I negotiated this route yesterday and it is impossible to pass through the existing gate with a push chair for two children, UNLESS two strong people are able to lift the pushchair over the gate, and under most circumstances mothers will be unable to do this if they are alone.

Your help in this matter would be appreciated.

Rolleston Civic Trust are looking into starting a new project that will increase the number of trees within the Parish Boundary. The starting point is to carry out a survey to see how many large mature and in the first instance deciduous trees we have. At the moment I am struggling to find a map defining the Rolleston Parish boundary and wonder if you have such a map that I can copy? Another aspect is knowledge of the land that the Parish Council own or are responsible for, like the Jinny trail and Taflands. Also have the Parish Council ever carried out a survey of trees in the Parish?
