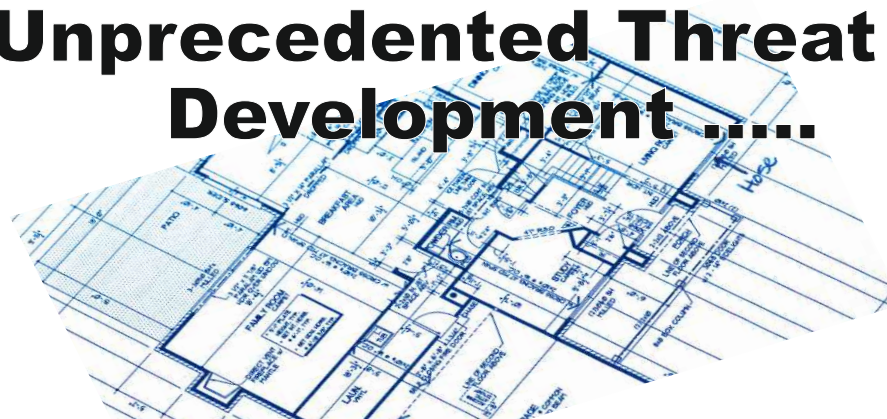

# Overview

The Parish Council have recently been made aware of Staffordshire County Councils (SCC) “aspirations” to develop land along Knowles Hill and Anslow Lane.

It is understood that these aspirations are for the development of between 150 and 300 dwellings along with a single site School to replace the existing two sites in the village. Ultimately this could also lead to further development in the heart of our community.

The Parish Council are against the principle of any development on this land and have written to SCC to advise them of this. We have also written to our MP, Andrew Griffiths, and asked him for his support.

## Planning - The Reality

The reality is that the Parish Council has very limited influence on planning matters and that is why it is essential to raise your concerns, the community, with the relevant authorities.
